b. BeautifySJ Grant: we were awarded the grant for next year and will work to continue improving our Los Paseos neighborhood.

C. Updates

- a. SJPD Update-- Christina Anaya
 - i. During past 90 days only four incidences have occurred in our neighborhood. Increase in burglaries, car jacking's, homelessness and blight are the issues of concern overall in San Jose (not in Los Paseos). The department is working to increase street crime unit, the burglary prevention unit and the truancy unit.
- b. D2 Office Update-- Vanessa Sandoval
 - Spoke about General Bond obligation measures. Measure T passed which will provide funding for public safety and helps protect Coyote Valley. Measure V (housing measure) did not pass.
 - Safe Parking is proposed to allow people to park overnight in certain areas. Pilot project will be allowed to park in Seven Trees Community Center overnight (less than 17 vehicles and only families-with children). Social workers, security, bathrooms, etc. will be provided as support.
 - iii. December 15th holiday party at Southside Community Center.
 - iv. Discussed updates on High Speed Rail and Vision 0 traffic regulations.
